_____ ANSWERING MACHINE? YES NO	I have a plan if problems or delays occur during my Fusion installation Cell phone# (optional) (____) _____-_____. You need to be present if inside wiring work is part of your install; otherwise, you do need to be at your home by 4 PM on the day of the transfer to confirm that everything is working. If we do not hear from you on your transition day, we will begin billing for the service.
Credit Card Bank Transfer	All FUSION customers <u>must pay by credit card or electronic fund transfer</u> , (circle one). Your service will now be billed from 1 st of month to 1 st of month. Some pro-rating of your bill will occur when your bill date is changed to the 1 st of the month.
_____	Customer is now responsible for all wiring from minimum point of entry phone box (MPOE). MCN does not offer WirePro service but will help you find a wiring consultant. Customer is responsible for all aspects of the local area network at their site. FUSION may not work if more than 5 jacks are used on the same phone line.
_____	Customer should notify MCN if there are two-line phone jacks, or other special phone equipment involved in their FUSION order. For best results, your DSL modem should be six feet away from any device emitting RF signal (TV, stereo speakers, answering machine, UPS etc.). <u>DSL is delivered on a "best effort" basis.</u>
_____	MCN Support hours are 9 AM to 6 PM Monday through Friday

Data transfer rates between customer premise and Central office are influenced by several factors including line quality and loop length. Customer must identify servers on FUSION lines. Customer may be subject to further charges for excessive bandwidth if servers impact the network. In the event underlying third parties terminate MCN's access to wholesale FUSION services, MCN may terminate this agreement. All accounts are covered by the MCN Acceptable Use Policy.
